## FULL PAYMENT IS DUE July 1, 2010

**1. Baggage Allowance:** Check with airlines for fees and weight of bags  
NO RESPONSIBILITY IS INCURRED FOR LOSS OF OR DAMAGE TO BAGGAGE OR ANY OF THE PASSENGER'S PERSONAL BELONGINGS. TRAVEL BAGGAGE INSURANCE IS RECOMMENDED AND AVAILABLE THROUGH KOLLANDER TRAVEL.

**2. Tour Price Excludes:** Airfare, Taxes, optional tours, telephone, telex, fax and telegram charges, excess baggage charges, sundry tips, laundry, beverages and food not on the regular table d'hôte menu (these items will be billed to you before leaving the hotel, or restaurant), portage at U.S./Canada airports and all other items of a personal nature. Service charges at hotels and restaurants are prepaid. **Travel Insurance is not included.**

**3. Refund and Unused or Amended Tour Arrangements:** Unused hotel accommodations, tour features or services are non-refundable, nor exchangeable for other accommodations, services or features.
